



Town of Champion Park Pavilion Use

TERMS AND CONDITIONS

- No one group may have use of the park so often that they exclude other groups. The Town reserves the right to refuse use of the park to any group at the Town's sole discretion.
- Public use of the facility shall not interfere with or take precedence over the Town's own needs for the facility.
- Advertising of an event or activity scheduled for a Town owned facility must identify the sponsoring group.
- Activities will be scheduled through the Town office. The Town requires a completed, signed contract for each use.
- When all terms of the contract have been honored and the park/pavilion is in acceptable condition, the deposit will be refunded. The removal of ALL TRASH/GARBAGE and the preservation of order is the responsibility of the applicant. If the Town must pay any charge or fee for the removal of trash or cleanup after use by the applicant, then said deposit shall be applied to such charges, and applicant, shall remain personally liable, for any such costs or claim.

RENTAL FEES

The TOWN OF CHAMPION reserves the right to waive fees for the non-profit organizations and/or Town sponsored functions. An advance deposit of \$50 is required to reserve the building.

Applicant shall not be relieved of such responsibility unless and until the pavilion and park facilities are returned to their original state, and all guests and invitees and other persons using the park/pavilion at applicant's event have been removed.

_____ Requester will indemnify and hold harmless the Town of Champion from any claim or cause of action based upon or arising out of the use of the park/pavilion by the applicant.

_____ When all terms have been honored and the park is in acceptable condition, the deposit will be refunded.
